



ASPL Developments in Pharmacy Law Seminar RELEASE AND WAIVER OF CLAIMS I understand that the American Society for Pharmacy Law ("ASPL") is hosting its 2021 Developments in Pharmacy Law Seminar at the JW Marriott Las Vegas at 221 N. Rampart Blvd, Las Vegas. [I acknowledge and agree that ASPL is offering participants the option of attending the Event either in-person or virtually (i.e., online).] By completing the in-person registration form, I [affirm that I am electing to attend the Event in-person and] acknowledge and agree to the terms and conditions set forth below.

- (iv) Washing hands frequently for at least 20 seconds and using hand sanitizer if hand washing is not readily available.

I agree that I will not attend the Event if I have been exposed to or tested positive for COVID-19 within the fourteen (14) days prior to the Event or if I am experiencing or have experienced COVID-19 symptoms within the fourteen (14) days prior to the Event. In addition, if I experience symptoms or test positive for COVID-19 at any time during the Event or within 14 days after participating in the Event, I will notify ASPL at administration@aspl.org. Please note, this information will be held strictly confidential. It will only be used to inform other Event attendees of the possibility of exposure (and such notice will not include your name).

I acknowledge and agree that I am attending the Event voluntarily and at my own risk, and that I release and waive any claim I might have against ASPL and its officers, directors, employees and agents for any and all liability or responsibility for any illness, damages, or injury whatsoever that I may incur in connection with my attendance at the Event, including, without limitation, as a result of exposure to COVID-19 or the manner in which the Event is conducted.
